SUPPORT FOR JOB REDESIGN UNDER PRODUCTIVITY SOLUTION GRANT (PSG-JR)

Workforce Singapore (WSG) has launched a new programme - *Support for Job Redesign under Productivity Solutions Grant (PSG-JR)* on 1 December 2020.

PSG-JR aims to make job redesigning easier by providing enterprises with JR consultancy support to complement and drive both their business and workforce transformation efforts.

Singapore National Employers Federation (SNEF) has been appointed as the Programme Manager (PM) to administer PSG-JR. Enterprises can apply for PSG-JR through the Business Grants Portal (BGP) after obtaining a quotation and a Job Redesign (JR) proposal from their preferred JR consultant. The panel of pre-approved JR consultants are listed on GoBusiness Gov Assist (https://govassist.gobusiness.gov.sg/productivity-solutions-grant/consultancy/jobredesign/).

*PSG-JR is now enhanced for a time-limited period to encourage and support more enterprises to redesign jobs and upskill workers amidst the current economic climate.

For your easy reference, funding parameters for PSG-JR are as listed:

Programme Duration	Up to 12 months to complete the PSG-JR project				
Eligibility Criteria	 All participating enterprises must fulfil the following criteria in order to qualify: Registered or incorporated and operating in Singapore; and Must have at least three local employees at the point of application In addition to the criteria above, at the point of application, applicant must NOT have: Made any payment to a pre-approved JR consultant or third party in relation to the engagement of JR-related consultancy service; and Signed or confirmed any contract or purchase order with a pre-approved JR consultant or third party in relation to the engagement of JR-related consultancy service 				
Funding	Enhanced funding for PSG-JR of up to 80% for consultancy services, capped at \$30,000 per enterprise till 31 March 2022. Thereafter, the PSG-JR funding rate will revert to up to 70% of the JR consultancy cost, capped at \$30,000 per enterprise. Eligible enterprises can also tap on the SkillsFuture Enterprise Credit (SFEC) to defray out-of-pocket (OOP) expenses. Eligible enterprises will receive a one-off \$10,000 credit per firm to cover up to 90% of OOP expenses. 新加坡劳动力发展局(WSG)于 2020年 12月1日启动了一项新计划:生产力提升计划一重新设计工作的津贴。

"生产力提升计划一重新设计工作"计划协助企业聘请获认可的"重新设计工作"顾问, 重新设计工作流程、职务和责任,使企业更容易推行业务和劳动力转型。

劳动力发展局已委任全国雇主联合会(SNEF)为项目计划经理,负责管理"生产力提升计划一重新设计工作"津贴。企业可以从被认可的顾问名单里索取有关顾问的报价和工作重新设计的建议书,再通过其商业资助网户(BGP)申请"生产力提升计划一重新设计工作"的津贴。已获认可的"重新设计工作"顾问名单可在 GoBusiness Gov Assist
